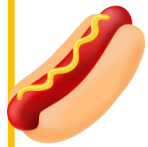

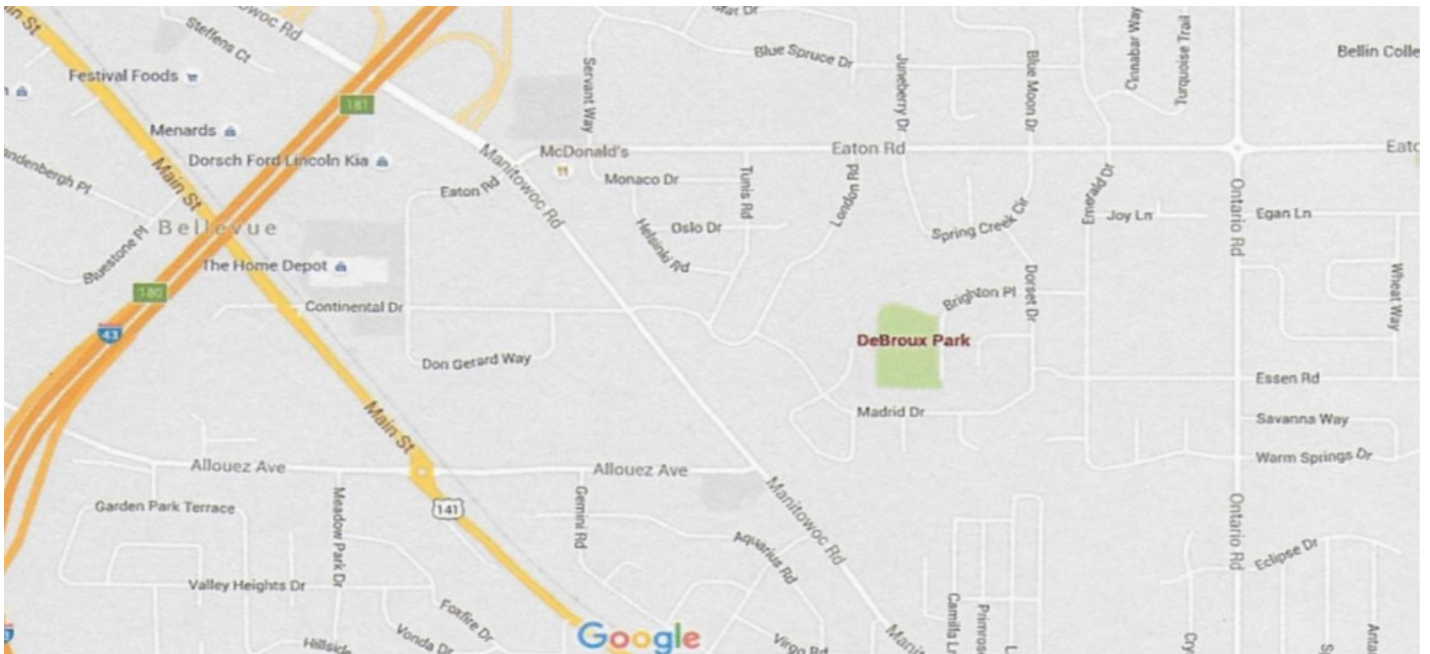

**NEW Woodworkers Guild Treasurers Report July 2021**

**Balance as of 7/26/21 - \$6,108.41**

Activity for the months of June and July

Income:

-\$465.00 from membership dues

Expenses:

-\$200.00 deposit for the annual show facility (Denmark H.S.)

-\$170.00 web Hosting fees.

-Tax filing fees, routine organization expenses, and virtual meeting hosting fees

Treasurer's Note: I noticed several months ago that there was a discrepancy in the reported balance between our financial software (Quicken) and our bank statements. Not to worry...the bank balance was always higher. In trying to find the problem, I tracked down several checks that were in the Quicken spread sheet twice. Meanwhile, in the last few months I have had a problem getting Quicken to link to the bank account to download data. I finally got the problem fixed. As of today, the bank balance is \$1771.36 higher than what Quicken shows. I will have to go through things month-by-month to see what is happening. Now for the good news: In May I listed our balance as reported by the Quicken software when I should have gone with the actual balance reported by the bank. As a result, our financial is much improved over what I reported in May, and we should have plenty of funds to "invest" in the upcoming Annual Woodworking Show.
